As the African swine fever situation worsens worldwide, this manual will assist veterinarians in the detection and control of the disease through methods such as improved border control, relevant awareness-raising, and improved biosecurity. (92 pp.)

CLIMATE CHANGE



[Adoption of climate technologies in the agrifood sector](#)

Given the food sector's contribution to greenhouse gas emissions, this publication provides a methodology to monitor market penetration and adoption of sustainable climate technologies (such as drip irrigation or renewable energy systems). (80 pp.)



[Drought characteristics and management in Central Asia and Turkey](#)


This report assesses drought impacts, such as soil water deficits, in Kazakhstan, Kyrgyzstan, Tajikistan, Turkmenistan, Uzbekistan and Turkey. It looks at exacerbating factors, such as political instability, and identifies policies to promote proactive drought management. (114 pp.)

An overview of the process and results of updating the global database for soil organic carbon content, now mapped to a resolution of 30 arcsec (approx. 1 km at the Equator). The database will inform carbon budgets and evaluations. (47 pp.)


[Child labour in agriculture in protracted crises, fragile and humanitarian contexts](#)

Promoting healthy development for children, this document gives recommendations for integrating child-labour sensitive activities in food security programmes, through partnerships, skills training centres, and data assessment. (24 pp.)



[Crop Prospects and Food Situation, No. 2, June 2017](#)

This quarterly report reviews the food situation by geographic region and lists countries requiring external assistance for food. This issue focuses on severe food insecurity in Africa, drought and conflicts in Asia, and record cereal production in Latin America. (40 pp.)

An analysis of medium-term market and policy developments affecting global markets of wheat, rice, meat and fishery products, amongst others. This issue includes features on the banana market and global liquidity in commodity price booms. (152 pp.)


