





FAO's work on climate change – United Nations Climate Change Conference 2017

This publication will be launched during the United Nations COP23, 6-17 November, Bonn. It presents FAO's key messages on climate change and food security and includes examples of FAO's support to countries so they are better able to adapt to the impacts of climate change in the agricultural sectors, including through land restoration, climate-smart agriculture and improved water management. FAO Food Price Index

The Food Price Index is a measure of the monthly change in international prices of a basket of food commodities. The FFPI averaged 176.4 points in October 2017, down 1.3% from September. Rice prices strengthened, while international quotations for butter, skim milk and whole milk powder eased.



Rural Africa in motion: dynamics and drivers of migration south of the Sahara

Through a series of maps and case studies, this atlas provides a global picture of migration drivers and dynamics. It calls for inclusive growth strategies to create rural-urban linkages, foster income-generating opportunities and increase the resilience of rural livelihoods. (60 pp.) FAO & CIRAD
